THE DANGEROUS VACCINE PROGRAM & OTHER ABUSIVE ACTS BY GOVERNMENTS & CORPORATIONS MUST BE HALTED

I received my Canadian citizenship, which is very important to me, in 1978 when I was ten years old. At a young age I learned about the [Canadian Bill of Rights](#) and later about the [Canadian Charter of Rights and Freedoms](#). The changes happening now threaten to erase the meaning of these documents and the sense of security their principles give many of us even as we navigate the sometimes harsh situations life presents.

I would rather that sense of security be shared with many generations into the future.

Everybody should be aware of the report published by Public Health Ontario “[Adverse Events Following Immunization \(AEFIs\) for COVID-19 in Ontario](#)” – a recent update is for “December 13, 2020 to October 23, 2022.” Heart issues are among the many adverse events included in this report:

There have been international reports, including from the United States and Israel, of myocarditis (inflammation of the heart muscle) and pericarditis (inflammation of the lining around the heart) following vaccination with COVID-19 mRNA vaccines.

An earlier report published by Public Health Ontario “[Myocarditis and Pericarditis Following Vaccination with COVID-19 mRNA Vaccines in Ontario: December 13, 2020 to November 21, 2021](#)” includes the following results for Ontario--the majority are under age 40:

- 423 total cases
- 125 of these were after dose 1 and 298 of these were after dose 2
- Ages 12-17: 77 cases, 18-24: 133, 25-29: 49, 30-39: 63, Ages 40+: 100
- Pfizer-BioNTech Comirnaty COVID-19 vaccine: 244, Moderna Spikevax: 179

The more recent October 23, 2022 AEFIs report lists 810 cases of myocarditis along with many other adverse reactions. Summarizing Table A1 for all COVID vaccine products:

- **Acute cardiovascular injury: 227**
- **Convulsions/seizure: 163**
- **[thrombocytopenia](#)** [low blood platelet count]: 87
- [Nodule](#): 86
- **Paralysis: 48**
- [Anosmia, ageusia](#) [loss of sense of smell/taste]: 45
- **[Guillain-Barré syndrome](#)** (GBS) ["rapid-onset muscle weakness caused by the immune system damaging the peripheral nervous system"]: 43
- **Acute liver injury: 38**
- TTS [[thrombosis](#) with [thrombocytopenia](#) syndrome] /VITT [vaccine-induced immune thrombotic thrombocytopenia]: 28
- [Oculorespiratory syndrome](#) (ORS): 27
- **Acute kidney injury: 27**
- [Myelitis/transverse myelitis](#) [inflammation of the spinal cord]: 22
- [Subacute thyroiditis](#): 20
- Single organ [cutaneous vasculitis](#) [inflamed blood vessels in the skin]: 19
- [Chilblain](#)-like lesions: 18
- **[Acute pancreatitis](#): 16**
- [Erythema multiforme](#) [target-like skin lesions on the hands]: 15
- [Rhabdomyolysis](#) ["serious medical condition . . . damaged muscle tissue releases its proteins and electrolytes into the blood"]: 15
- [Encephalopathy/encephalitis](#) [brain disease / inflammation]: 12
- **[multisystem inflammatory syndrome in children/adults](#)** ["different body parts become inflamed, including the heart, lungs, kidneys, brain, skin, eyes, or gastrointestinal organs" – note how the CDC says this is "associated with COVID-19" (<https://www.cdc.gov/mis/index.html>)]: 11

- [Parotitis](#) [inflammation of the salivary glands]: 7
- **[Acute respiratory distress syndrome](#): 4**

- [Kawasaki Disease](#) ["blood vessels become inflamed throughout the body"]: 1

From this report, and from adverse events reporting systems for [Canada](#), [US](#) and [Europe](#), we know that there are many adverse reactions reported for COVID-19 vaccines, including deaths (see health-infobase.canada.ca/covid-19/vaccine-safety/ vaers.hhs.gov/data.html www.adrreports.eu/en/index.html).

These vaccines are hurting many people, which makes it even harder to justify coercion. Therefore, the COVID-19 vaccination program needs to be shut down and investigated.

Constant propaganda has accompanied intimidating, coercive measures such as vaccine passports and mandates—along with lockdowns, stay-at-home orders, isolation, masking, and social distancing. These measures, which are used to bully the public into taking these dangerous, novel and experimental mRNA drugs, violate multiple domestic and international laws expressing the principle of informed consent.

This situation is equivalent to assault under the *Criminal Code*.

Many laws have been broken throughout COVID events, including the Ontario [Health Care Consent Act](#), multiple sections of the [Charter of Rights and Freedoms](#) and multiple other sections of the [Criminal Code](#) (including, for example, fraud and criminal negligence causing death).

To be clear about related issues, in addition to vaccine injuries, the evidence shows:

- that a false impression was deliberately created about a shortage of resources,
- the COVID death numbers have been inflated by redefining cause of death,
- the case numbers have been inflated through dubious tests, and
- many of the elderly and others have been denied proper health care through explicit COVID euthanasia/rationing policies and by suppressing available treatments.

I have assembled documentation containing references, an outline of evidence and details I have selected to illustrate the nature of the real problem, and what offences I think are being committed.

Please act to inform, protect and seek justice for your fellow Canadians.
